


Always engage the trigger lock when sprayer is stopped to prevent the gun from being triggered accidentally by hand or if dropped or bumped.




Pressure Relief Procedure




This equipment stays pressurized until pressure is manually relieved. To help prevent serious injury from pressurized fluid, such as skin injection, splashed fluid and moving parts, follow the **Pressure Relief Procedure** whenever sprayer is stopped and before sprayer is cleaned or checked, and before equipment is serviced. 1. Engage trigger lock.



2. If applicable, turn electric motor ON/OFF switch to **OFF** position. Wait 7 seconds for power to dissipate.



3. Unplug power cord or shut engine off.



4. Disengage trigger lock.




5. Hold a metal part of the gun firmly to a grounded metal pail. Trigger the gun to relieve pressure.

Solvent and oil-based fluids: follow local code. Use only conductive metal pails, placed on a grounded surface such as concrete.


Do not place pail on a non-conductive surface such as paper or cardboard which interrupts grounding continuity.




6. Engage trigger lock.




 Open any fluid drain valves in system. Leave drain valves open until ready to spray again.



8. Remove pin then remove pump.









1. Remove Pump Rod Adapter.




2. Unscrew cylinder from intake valve.



3. Loosen and remove packing nut.



4. Tap piston rod out of cylinder with a plastic hammer being careful of the threads. Use a thin, soft rod if necessary.







Do not clean or wipe the piston valve threads. Cleaning the piston valve threads could destroy the special sealing patch and cause the piston valve to come loose during operation, causing a pump burst and possible serious bodily injury.


5. Unscrew piston valve from piston rod.



6. Remove piston from displacement rod. Clean and inspect parts.




7. Remove and discard throat packing and glands from the cylinder.






1. If applicable, soak leather packings in SAE 30W oil for one hour before assembly.




2. Assemble packings and ball to piston and piston rod.



3. Torque to 85 ± 5 ft-lb (115 ± 7 N•m).




4. Assemble throat packings and place in pump cylinder.




5. Apply liberal amounts of grease or oil to piston packings. Grease top inch or two of piston rod that will go through the cylinder throat packings.




6. Gently guide displacement rod up through throat packings. Tap bottom of piston valve as necessary with a leather or plastic hammer.



7. Grease o-ring and place on outside diameter ring groove.




8. Clean seat thoroughly. Reassemble intake valve with a seat, ball, and new o-ring. Seat may be flipped over and used on other side.




Torque foot valve to 290± 10 ft-lb (393 ± 14 №m).




 Install O-ring and Packing Nut. Torque packing nut to 25 ± 5 ft-lbs (34 ± 7 N•m).



11. Install pump rod adapter, torque to 35 ± 5 ft-lbs (47 ± 7 N•m)








Throat Packing Adjustment

When pump packings begin to leak after much use, perform **Pressure Relief Procedure**, page 4, and tighten packing nut down until leakage stops or lessens. This allows approximately 100 gallons of additional operation before a repacking is required. Packing nut can be tightened without o-ring removal.
